**NOTICE OF DEFENDANT’S FILING OF
SUPPLEMENTAL COURT REPORT**

Introduction

Defendant, Huntsville City Board of Education (the “Board” or the “District”), files this day a Third Supplemental Report with the Court (hereinafter, collectively the “Third Supplemental Report”) to provide the Court notice of an error in Report V.D.1 in the Sixth Consent Order Report. (Doc. 698-6, pp. 1-6). This Third Supplemental Report will provide the Court with an explanation of the error and will attach, as an exhibit, a corrected version of the report.

V. FACULTY

V.D.1.: *For the 2019-20 school year*, a list of the members of each committee involved in the recruitment, hiring, assignment, retention, or promotion of administrators, faculty, and certified staff. The list will include: name of committee; each committee member's name; his or her race; position (title and location) and date(s) on which he or she served on the committee.

Notes:

Report V.D.1 filed on November 15, 2020, contained an error in the column titled "Race." (See Doc. 698-6, pp. 1-6). The filed report incorrectly showed that, of the committee members listed, 34 were Black, 39 were Other, and 1 was White. The report incorrectly labeled the race of many committee members listed on the spreadsheet. The District is not sure what caused this error. However, the District will check for this mistake in future reports to ensure it does not happen again.

Attached hereto, the District has provided a corrected version of report V.D.1. The corrected version shows that, of the committee members listed, 35 were Black, 37 were White, and 2 were Other.
